BY MY INITIALS BELOW, I AGREE TO THE FOLLOWING POLICIES:

- _____ A once-a-year enrollment fee of \$40.00 is due annually for each student.
- _____ Tuition is due by the 1ST OF THE MONTH . A Late Fee of \$15.00 will be added to the tuition rate after the 10th of the month.
- _____ One-half month's tuition is due for the month if I wish to "hold a spot for my child(ren)" in a class that he/she is not attending for that month only.
- _____ Notice must be given to the Ballet Academy of Texas office staff by the 1ST OF THE MONTH IF MY CHILD IS DROPPING A CLASS OR I WILL BE LIABLE FOR THE TUITION FOR THAT MONTH.
- _____ Make-up classes are available for missed classes within the same calendar month. Advance notice to attend is not required.
- _____ Semester payments are non-refundable.
- _____ Ballet Academy of Texas's tuition is based on a 4-week class month. There may be up to 4 weeks annually for which you are not charged. These weeks cover holidays and other closures throughout the year. (52 weeks - 48 class weeks paid = 4 extra weeks per year). Therefore, a full month's tuition is due for the months such as December with holidays.
- _____ I agree that physical contact between teacher and student is sometimes necessary for the proper training in any dance form.
- _____ I am aware that there is a certain degree of risk involved in all physical activity, and that potentially severe injuries can occur. It is the express intent of the Ballet Academy of Texas Corporation to provide a safe environment and correct training in order to avoid any and all injuries to my child(ren). Therefore I agree to release the Ballet Academy of Texas Corporation from any liability should my child become injured while under the Ballet Academy of Texas' supervision.
